CONDITIONS OF ENTRY:

1. Artwork is to be delivered to the Rendezvous Room located in the Waymire Complex (Dome), Friday, July 27, 2012 from 5:00 p.m. to 8:00 p.m. Release will be Sunday, August 5, 2012 from 5:00 p.m. to 6:00 p.m. No pre-registrations.
2. Exhibits are limited to original work having been executed within the last two years.
3. Artwork must be an original piece and not a copy of another artist's work.
4. Artwork having been shown at a previous Adams County Fair will not be accepted.
5. Digital or computer enhanced work will not be accepted. Only traditional forms of fine art work will be accepted.
6. Maximum size of paintings = 1260 Sq. inches or length x width of outside frame measurement
7. Sculpture – Adult division ONLY: Traditional 3-D artwork made from clay, bronze, wood, or other approved materials. Maximum 30" in height.
8. There will be a professional judge. Judge or Superintendent may move or regroup art pieces. Decision of the judge is final. Classes may be divided or combined at Superintendent's discretion.
9. Customary care will be taken in handling artwork, but it will be shown at the artist's own risk.
10. In the Junior division, a fee of \$1.00 for each piece of artwork, limit three per exhibitor. Adult division, a fee of \$5.00 for each piece of artwork, a limit 10 per exhibitor.
11. Junior division artwork must be framed, matted, or backed by cardboard, and ready for hanging on peg board with either wire or bull dog clips, otherwise they cannot be entered. Adult division artwork must be framed and equipped with wire hangers only; no saw tooth hangers, and no wet paintings will be accepted.
12. In both Junior and Adult divisions, ribbons and cash prizes will be award in 1st, 2nd, and 3rd places, ribbons only for 4th place. All Junior entries will receive a participation ribbon. A Best of Show Overall in each division will be awarded.
