The University Curriculum Committee (UCC) reported its actions periodically through the minutes approved by the Faculty Council. Copies of the UCC minutes and minor curriculum changes are posted on the UCC web site (<http://www.colostate.edu/Orgs/ucc>). In addition to the usual curricular items in the form of course and program proposals, the Committee:

1) Transmitted to the Faculty Council as special action items:

- a) Add a new graduate interdisciplinary studies program in systems engineering.
- b) Drop the exercise science and nutrition graduate interdisciplinary studies program.
- c) Add a master of applied industrial/organizational psychology (plan C).
- d) Add a master of natural sciences education plan C (M.N.S.E. program).
- e) Add a new interdisciplinary studies program in Italian studies.
- f) Add a major in landscape architecture (plan C).
- g) Add a major in ethnic studies.
- h) Add a plan B to the apparel and merchandising specialization (M.S. degree program).
- i) Add a minimum grade requirement to the equine science major.
- j) Add a minimum grade requirement to the applied statistics minor.
- k) Add a minimum grade requirement to the environmental sociology concentration.
- l) Add a plan B to the foreign languages, literatures, and cultures, Master of Arts.
- m) Add a plan B to the interior design specialization under the Master of Science degree in design and merchandising.

2) Other major actions submitted to Faculty Council through the minutes:

- a) Add the systems engineering specialization to the master of engineering (plan C).
- b) Add a concentration in landscape business to the major in landscape horticulture (B.S. degree program).
- c) Drop the concentration in science in the rangeland ecology major (B.S. degree program).
- d) Add a specialization in nutrition and exercise science to the master of science (plans A and B) in food science and nutrition.
- e) Add a specialization in exercise science and nutrition to the master of science (plan A) in health and exercise science.

- f) Add a minor in Chinese.
- g) Add specializations in human-environment interactions to the master of science and the Ph.D. in ecology.
- h) Add a concentration in environmental sociology to the major in sociology (B.A. degree program).
- i) Change the name of the communication development option in the major (M.A. degree program) in English to creative nonfiction specialization.
- j) Add the AGED, Agricultural Education, prefix.
- k) Add a specialization in financial risk management to the M.S. program in business administration.
- l) Transfer the GR (geography) prefix and all its courses from the Department of Forest, Rangeland, and Watershed Stewardship to the Department of Anthropology.
- m) Drop the requirement for transfer student in the Department of Mathematics. (Transfer students must complete a minimum of nine upper-division credits in mathematics at Colorado State, excluding MATH 315, MATH 340, and mathematics courses ending in -80 to -99).
- n) Add a specialization in pest management (plan B) to the master of science in bioagricultural sciences.
- o) Drop specializations in entomology, plant pathology, and weed science under the master of science (plan B) in bioagricultural sciences.
